DRIVER EDUCATION COURSE

1. Preston Driving School will give 24 classroom hours of instruction in Segment I and 6 classroom hours of instruction in Segment II.
2. Preston Driving School will give 6 hour of behind the wheel instruction during Segment I.
3. Preston Driving School will supply a dual-controlled car, completely insured and a licensed instructor.
4. If a student does not pass or complete the written or driving portion of driver education within a two week period, he or she must retake the whole class over again. The charge for the retake will be \$170.00.
5. If the student needs additional driving time during this two week period. It will be made available at a cost of \$30.00 per hour.
6. After passing Segment I the student will be issued a Michigan Driver Education Certificate of Completion showing that they have passed Segment I.
7. There will be a \$10.00 replacement fee for Certificate of Completion that is lost, damaged or stolen.
8. To enroll with the Preston Driving School the student must have a valid copy of their birth certificate.
9. A \$20.00 book charge if the book is lost or damaged.
10. The driving record of each individual instructor is available for review upon request.

Outside the classroom instruction time, your child will be driving for a minimum of six hours on Michigan roads and highways with a highly qualified instructor.

During the six hours of road time, your child will have various types of driving experiences. Beginning with the most basic driving tasks and ending with more difficult driving tasks.

After completing Segment 1, each student will possess the necessary knowledge and skills to begin Segment 2.

Students are required to select a driving partner for the six hours of roadway instruction. The students will drive with their partner in two-hour blocks.
